From I-287 Northbound: Take Exit for Route 22 West (exit from the left lane). Get off at the Grove Street/Somerville exit. Proceed as above.

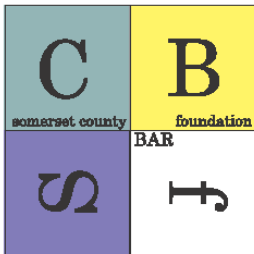
## SOMERSET COUNTY BAR FOUNDATION
